

## Extended Care Options: 2018-19

The Gardner School of Arts & Sciences offers **extended care on school days**:

- **Before care** - Kalama-Tahoma students each school day, 7:15-8:15am
  - Before care is not available for Tumtum and Mazama students. Please drop off your students in their classrooms no earlier than 8:15am
- **Early Childhood**: Lunch Bunch (12:00pm - 1:00pm) and Aftercare (1:00pm - 6:30pm)
  - Space is limited and subject to availability.
- **Kalama Aftercare**: 1:45pm - 6:30pm (Sep-Dec); 3:30pm - 6:30pm (Jan-June)
- **Loowit - Tahoma Aftercare**: 3:30pm - 6:30pm

Extended Care Costs:

- Before school care: **\$9.00/hour** // After school care: **\$9.50/hour**

Extended Care Contracts are available for reduced rates. Special rates for In-Service and other non-school days may apply.

*Parents who are on campus for any purpose during extended care hours must decide if their child is to remain with the extended care provider or with the parent. If the child remains with the program, the parent will be charged for the time. Gardner reserves the right to deny extended care for repeated late pickups or payments, or failure to abide by other extended care guidelines specified in the Parent Handbook.*

### Option 1: Drop-In

Parents may use Extended Care as needed on a drop-in basis. Drop-in Extended Care ends at 6:30pm. There will be an additional charge of \$1.00 per minute after 6:30pm. The Business Office will bill parents monthly for Extended Care use. *This replaces the punch-card system.*

**Early Childhood Extended Care**: Space is subject to availability and is not guaranteed except by children with an Extended Care Contract (see below).

### Option 2: EXTENDED CARE CONTRACT/REDUCED RATE PLAN

Extended Care Contracts are available to families who would like to reserve extended care space(s) at approximately **40% off** compared to drop-in extended care rates (plus no charge for before-care). Families who elect the Extended Care Contract/Defined Rate Plan may use any extended care service to the full extent specified by your contract. An additional 25% **sibling discount** on the lowest priced plan is available (one discount per family).

*Refunds are not available for unused contract time; unused contract time does not carry over to subsequent school years. Contracts may be terminated or transferable to another student upon approval by the Head of School. Gardner reserves the right to terminate a family's extended care contract for repeated late pickups or failure to abide by other extended care guidelines specified in the All-School & Community Handbook.*

Cash or Check payments are due by September 10, 2018 and January 7, 2019. Monthly payments may be established (nine automatic payments). For more information, contact Sheila Hughes - shughes@gardnerschool.org.
